UNAPPROVED SELECTBOARD MINUTES

January 28th, 2019

7:04 Meeting to Order by Lou Beam.

Chairman, Bud Ross, was unable to attend the meeting.

Minutes for the January 14th Meeting were accepted as written. (2-0)

Lou Beam reviewed the Town Calendar.

The Board opened the Public Budget Hearing.

Lou started the meeting by noting that the budget was up 3.4% from last year totaling \$19,071. He then proceeded to go over the budget line by line. It was discussed that the Town may want to consider a reserve fund for payment on the Fairpoint legal battle. Ken Urbanski asked about this and Bob Cunniff noted that the case concerns the taxation of the service and that the Town may be held liable for past taxes and interest which may total \$20,000 or so. Lou discussed the overage on the General Government Building budget, the majority of that due to a project on the Meetinghouse. The Town was reimbursed by the Heritage Commission \$29,632, which is shown on the revenue side. Lou mentioned that the project did go over the budget by \$7,000 but that it was decided to paint the entire Meetinghouse. Lou also discussed the necessity of installing a new A/C and heat system upstairs in the Municipal Building because the A/C unit failed. The Police Department and budget were discussed. Ken asked about the consolidation. Lou discussed why the consolidation was not financially feasible for the Town. The coverage and projected coverage from the department was discussed, as well as the hiring of a new chief. Nate spoke to the Fire Department budget increase noting that the Mutual Aid fee has increased and there are two new volunteers that will need gear. Lou went over the Highway Department budget. He said that the prices for salt, sand and gravel have all increased. He also brought up that the Board had wanted to add \$10,000 to the budget for the purpose of purchasing and stockpiling gravel. Lou discussed the capital outlay purchases. He went over the paying of the lower part of Holden Hill that is currently dirt. He also went over the plans to paint the old Fire Station and redo the town common by the Meetinghouse. Bob brought up that the trees would be urban trees meant to withstand the abuse from the roads. Lou went over the chapters for the Master Plan and the proposed work to be done on the old Salt Shed. Lastly, the Board discussed the monies going to the capital reserve funds and the reasons the funds are needed.

Lou went over that the school tax rate should be going down again this year; he also brought up that the deliberative for the School is scheduled for February 6^{th} and that it is an important meeting and urged people to go.

The Board thanked everyone for attending.

- 3. Lou discussed the plans for a closet off of the voting room funded by the Community Club.
- 4. The Board reviewed and signed orders.
