UNAPPROVED SELECTBOARD MINUTES

October 9th, 2019

7:00 Meeting called to Order by Chairman, Lou Beam.

Lou Beam reviewed the Town Calendar.

Lou mentioned that the Planning Board may not be having a meeting on the 15^{th} as they have a meeting planned for the 29^{th} to go over two modules for the Master Plan.

The Board noted that they are back to meeting on a weekly basis.

Recognition of Visitors:

The Board recognized Doug and Gina Beach. It was noted that the overall town budget may be tight this year. Doug discussed that he could keep his budget down to \$5500 if needed. He said he does have fall cleanup still and the Cemetery Committee had discussed stone cleaning and the taking down of some trees. He mentioned that the equipment did not need any servicing. Doug also brought up the land survey for the cemetery needing to be done. Jess said she planned to have it done when the town's tax map is updated. Doug did mention cleaning the vinyl fence as well. Lou said that even though the budget will be close, the cemetery should go ahead with the projects they budgeted for. Doug will buy the cleaner for the stones and will ask for volunteers to keep costs down. The Board thanked Doug.

The Board welcomed Fire Chief, Greg Chaffee. Greg's budget looks good but he said he still has a \$6,000 grant to pay towards kits in case of a school situation. The money would be reimbursed by the State but go back to the general fund. Greg said he also needed to purchase gear for two volunteers and had vehicle maintenance and monthly bills left. He said he may come in \$1,000 under budget. The Board thanked Greg.

The Board welcomed Everett Adams.

Old Business:

1. Nate discussed with the Board a class action lawsuit being brought forth by the State in regards to the National Prescription Opiate Litigation. He said the town would be part of it unless we determined to exclude itself or sue on its own. Nate thought whatever came from the lawsuit would be minimal for the town.

New Business:

- 1. The Board reviewed a letter from the DRA with the approval to overspend the budget to settle with NNETO and repair the Crane Brook Bridge.
- 2. The Board reviewed and signed Payroll.
- 3. The Board reviewed and signed Orders.
