UNAPPROVED SELECTBOARD MINUTES

May 6th, 2019

Recognition of Visitors:

The Board welcomed Mike Herrington, School Board Chair. Mike discussed that the School Board would like to organize a committee to review and perhaps revise the Articles of Agreement. They would like to have this committee working at the same time as the withdrawal study was happening. He noted that the withdrawal committee will not be examining the Articles of Agreement. Mike is looking for two residents from each town to participate; preferably a parent of a current student and a member of the general public. The Articles of Agreement have not been revised since 2007; Mike believes they should be redone every 10 years. Mike also discussed with the Board that he would like to work on communication between the School Board and the towns. He would like to have a Board member attend a Selectboard meeting once a month. The Selectboard and Mike did discuss the need for more state funding and the Conval legal situation. The Board thanked Mike for attending.

Old Business:

2. The Board discussed the Flammable Cabinet for the Highway Garage. Jess will order it- will come out of the General Gov't Buildings budget.
