- 1. The Board discussed that the SRO position will be at the end of the eighteen month waiting period at the end of February or early March. The Board thought to ask the Town Attorney to script a letter letting Rosemary know that her position will be terminated on that date and the Town will advertise for a replacement.
- 2. Lou discussed with the Board the SAU 60 budget. \$340,000 was added to the budget at the Weds budget meeting. Lou also discussed how much surplus the school had in its budget from 2011 to 2017;\$299,000, \$300,000,\$962,000,\$528,000, (\$42,000),\$215,000,\$413,000 respectively. They discussed the default budget and noted that there will be a deliberative session on February 7th. They also went over the schools' budgets noting the increases.
