# **UNAPPROVED SELECTBOARD MINUTES**

# November 19<sup>th</sup>, 2018

7:00 Meeting to Order by Lucien Beam.

Bud Ross was unable to attend the meeting.

## Minutes for the November 5<sup>th</sup> Meeting were accepted as written. (2-0)

Lou Beam reviewed the Town Calendar.

#### **Recognition of Visitors:**

Roger said that he couldn't see why he wouldn't be able to produce the sand; he should be able to continue screening despite the weather. The Board also discussed the gravel stockpile with Roger. Roger assured the Board that he would have the remaining gravel ready for June of next year at the latest. The Board thanked Roger for coming.

Bud joined the meeting, briefly, to sign paperwork.

2. The Board reviewed and signed POs for the Road Agent.
