#### UNAPPROVED SELECTBOARD MINUTES

April 2<sup>nd</sup>, 2018

7:00 Meeting to Order by Bud Ross, Selectboard Chair.

Minutes of the March 26th meeting accepted as written. (3-0)

**Bud Ross,** reviewed the Town Calendar.

Recognition of Visitors: Alan Dustin, Carolyn Urbanski.

Alan Dustin spoke to the Board on behalf of Horst Meyerrose. He said Mr. Meyerrose was attempting to sell his home and that the potential buyers would not purchase due to the home across the street. Alan said that he did not believe the house had a septic and there was a camper parked there that was being used as a dwelling and did not have the right setback. He also mentioned that the house had water rights to Mr. Meyerrose's and that the number of people living in that house was overburdening the system. Mr. Meyerrose did believe that the septic at the house had failed and the runoff was going into a pond on his property. Alan did speak to Everett Adams, building inspector. The Board agreed to ask Everett to take a look at the place and let them know that the camper cannot be used as a dwelling and needed to be properly set back from the road and to check the septic situation. The Board would be in contact with Alan.

#### **Old Business:**

- 1. The Board discussed a Schoolboard and Selectboard Meeting that would be held on April  $11^{th}$  from 5-7. The Selectboard members thought that they could all attend.
- 2. The Board reviewed the Highway Budget to date and will look into it more next week.
