# May 15<sup>th</sup>, 2017

### 7:00 Meeting to Order by Ronald Batchelder, Selectboard Chair.

Present: Ron Batchelder, Bud Ross and Lou Beam.

The Ordinance rules will have to be added as a Town Warrant Article for the next Town Meeting and voted on during elections.

2. The Board discussed another quote on the replacement of the glass at the Food Shelf for \$600 and are awaiting another quote from a local vendor.

3. The Board discussed that the School Resource Officer has agreed to attend a June 12<sup>th</sup> meeting to discuss the upcoming contract renewal. The School is working on their revisions and it must be signed by the end of June.

5. The Board reviewed a quote from Dean Tasker for the repairs to the Carriage House floor. The Board is still waiting on other bids to come in.

#### New Business:

1. The Board noted that crack sealing would begin on Cheshire Turnpike either Tuesday or Wednesday of this week.

2. The Board reviewed and signed a PO for the Road Agent. The Board also discussed a culvert on Hemlock Road that may need repairs as brought to their attention by a resident.

3. Lou mentioned that an Intent to Cut would be coming in from the Koss's; he said that the operation would go off of 12A.

4. The Board discussed that Michael Gordon had been in to go over the office computers and he had some advice on the other computers and programming.

5. The Board reviewed and signed payroll.
