7:00 Meeting to Order by Selectboard Chair, Bud Ross.

#### **Recognition of Visitors:**

The Board recognized Rob Koester, VP of Consumer Products with Consolidated Communications. Rob discussed that Consolidated Communications' business plan differed from Fairpoint's. He said that they planned to invest a lot of money is cable maintenance and upgrading speeds in the area. He mentioned that 40% of the Town is already available for upgrades and can be checked on their website. He also mentioned that 97% of the Town will see faster service by the end of 2018. He did mention that for the remaining 3%, who live far from the boxes and will see little speed increase, the company is working on alternate choices that will be ready by March of 2019. Rob answered questions and asked residents to contact him with any issues they have. The Board thanked Rob for coming.

The Board recognized Judy Aron. Judy is running for State Representative seat -Sullivan #7. Judy noted that she is attending Selectboard Meetings to see what towns are facing for difficulties. She said that the most noted are roads, schools and rising taxes; to which the Board agreed. Judy also mentioned that she is on the Acworth Budget Committee. Judy said that she planned to continue going to Selectboard Meetings and Planning Board Meetings to keep the pulse of the communities. The Board thanked Judy for coming.
